Council President Anne Marsh welcomed all in attendance and called the meeting to order at 10:07 a.m.

- No representatives from the public were present to address the Board.

Approval of Minutes

Minutes from the NVEMSC Board of Directors held December 17, 2020, were sent for review by email

- Kate Kramer made a motion to accept the minutes from the December meeting as written, seconded by Brian Hricik
 - The minutes were unanimously approved.

Treasurer's report

- The Treasurer's report was sent via email for review along with the financials for December and January.
 - Brian Hricik made a motion to accept the Treasurer's Report as submitted, seconded by Kate Kramer.
 - The report was unanimously approved.

President's Reports

President Anne Marsh advised there was no report for this meeting. We are pleased that vaccinations are being rolled out throughout the region for administration.

Executive Director's Report

- The DHS contract for Dulles Airport was extended through June 30, 2021.
 - The staff remains in a ready reserve status with no indications of redeploying.
- The Council received 1520 Abbott BinaxNOW COVID-19 Antigen Test Kits
 - There are 40 test cards per box
 - They are to be used within 7 days of symptom onset
 - There is a weekly online training for the test cards through Abbott
 - The Council has a regional CLIA Waiver for these tests
 - There is reporting data that is required immediately after each test
 - Please email the Council if you'd like to get a box of tests and you'll be forwarded the link for the training and the reporting requirements
 - All tests expire in early or mid-May 2021
 - Dr. Sullivan asked if anyone is asking ride-alongs if they've been tested
 - Brian Hricik from Alexandria Fire advised they have no mandate for staff or students
 - Prince William County has no mandate for staff, unsure about students
 - There are bi-weekly meetings with Inova Blood Donor Services
 - They are going to look into UASI funding for infrastructure for regional equipment and 100 units of whole blood for circulation
- The financials remain solid and the second quarter reports have been submitted to OEMS
- Ashes2Art continues to have classes for first responders, law enforcement, and their families free of charge
 - They are working on a mindful decontamination kit which will be a tangible toolkit with items for distressing

- They are currently working on what these kits will look like for different people and their experiences
- Kathy recently finished a blog post on her interview with Daniel Sundahl. He is a paramedic and a very talented artist.

- Craig is having weekly meetings with Alan Stillman from Stroke Smart
 - They're working on videos for government entities on how to be a Stroke Smart Community
- There is virtual burn training in March with MedStar
- Our first Acute Systems of Care meeting will be next Wednesday, February 10, 2021
 - This will focus on bringing out of hospital Cardiac Arrest, Stroke and STEMI partners together to share and collaborate on care across these systems of care

AHA Training Center

Ray Whatley provided the following report.

- All AHA Instructors and Training Centers must be teaching the 2020 Guidelines healthcare courses (BLS, ACLS, PALS) using 2020 Guidelines course materials. This was effective **February 1, 2021**.
- All Training Site Coordinators have received the new 2020 Exams. Instructors that need access to the exams should contact their Training Site Coordinator.
- The existing inventory of **2015 BLS, ACLS, and PALS eCards**, has been automatically transitioned to 2020 inventory.

 - The trauma topic was tourniquet use
 - The medical topic was cardiac arrest
 - The system topic was the use of First Watch/First Pass

Medevac Committee

Paul DeHaven advised there was no meeting held and no updates are available.

Regional Medical Directors & State Medical Direction Committee

Dr. Morgan reported the following:

- They meet every two weeks virtually to discuss COVID, DEA regulations, vaccine information, etc.
 - These are not official business meetings because they're held virtually
 - They must have official meetings in person so they are awaiting the lift of restrictions
- During the most recent state meeting, they discussed the feelings on vaccinators below the level of AEMT and paramedic
 - The OMDs agreed to allow AEMT to vaccinate as it's in the Scope of Practice
 - Loudoun County starting using them this week
 - There is legislation to consider using basic EMTs and even those recently expired in the last few years. This will not include EMR level
 - There are concerns with EMS providers drawing up meds and changing concentrations for certain vaccines
 - If the EMTs are used, they'll have the meds drawn up by an ALS provider then the EMT can administer
 - This is still under consideration and has not been finalized

Training and Certification Committee

Michelle Ludeman provided the following report:

- They have not met in person since last year
- There was an EC Update sent by email from Chad Blosser
- National Registry has updated its website
 - VA OEMS has created the NREMT Recert 2.0 and it is on their website to assist providers
- National Registry has provision certifications that will expire December 31, 2021.
 - If the psychomotor exam hasn't been completed by January 1, 2022, they will report this to the Regulation and Compliance Division of VA OEMS and the provisional certification will be revoked
- There is a data exchange issue with National Registry and VA OEMS
 - Virginia doesn't provide provisional certifications for EMT & EMR but the National Registry does
 - People are getting cards from National Registry but they aren't being sent to VA OEMS
- National Registry is conducting continuing education audits
 - They will reach out to Debbie Akers at OEMS to verify and assist with the audits and verify the continuing education records
 - Please keep your records together by recertification date in case you are audited and need to provide proof

Other Committees

VAGEMSA

Brian Hricik advised of the following update:

- A virtual meeting will be held on March 5, 2021, and an email invite was sent out
- They plan to discuss HB1818 for workers comp to include EMS in the Heart Lung Bill
 - On the Senate side, they eliminated the retroactivity but going forward it could be included if it passes
 - Because of the retroactivity being removed, anyone currently on the job won't be covered, only those hired now and going forward
 - There is also a locality option that will go to County and City officials to get it added to benefits
 - The hope is for presumptive positive if you got hired already and passed a physical then got diagnosed later you could be covered
 - If localities don't sign on, it's more of a decorative bill than useful
 - COVID "essential worker" bill latest information is that you must have a positive diagnosis by a physician, not just a presumptive positive.
 - One is for law enforcement, one is for EMS, firefighters, and healthcare providers only
 - This is also not retroactive at this time

JURISDICTIONAL REPORTS

City of Alexandria Fire Department

Deputy Chief of EMS Brian Hricik provided the following update:

- They are in the process of significant changes due to reorganization
 - They are creating a Battalion Management Team that will consist of a Battalion Chief and an EMS Captain on the east side of the city
 - On the west side of the city, it will be at Battalion Chief and their aide
 - This will allow the teams to work together in one vehicle
 - They are deployed in a quad cab truck with a box
 - They are promoting 14 EMS lieutenants that will go to EMS chase cars
 - A Shift lieutenant will be on three of the six transport units as FTOs
 - One EMS lieutenant will go to EMS training and MIHCP
 - There may be some changes with moving apparatus but they will notify everyone when the time comes
 - They are relocating specialty service units
 - MOT will go from Station 201 to Station 204
 - Hazmat on the north side will go to the west side of the city
 - Rescue 206 will go to the northeast end of the City at Station 209
 - Technical Rescue is being moved to the east end of the city
- Two new Braun ambulances have been received and will go into service this month

- Chip Myers who is an Alexandria Retiree and has been active in EMS in VA, NC, and WV was diagnosed just before Christmas with COVID-19 and was eventually transferred to Johns Hopkins Hospital
 - He has been on ECMO for a month and is being weaned off now
 - Byron Andrews has been the family liaison
 - Please keep Chip and his family in your thoughts and prayers

Arlington County Fire Department

EMS Battalion Chief Anne Marsh provided the following update:

- They currently have zero quarantined or isolated employees at this time
- Kate Kramer is working diligently on the vaccine programs in the county
 - Kate advised of the following information:
 - 76% of the staff has received a vaccine in their department
 - They are staffing a BLS ambulance at Public Health during vaccine clinics to handle any BLS reactions that do not require transport such as oxygen, Benadryl administration, etc.
 - 27 AL providers are fully trained vaccinators integrated with the Public health Clinic and they are currently discussing creating a mobile clinic
 - Kate asked if anyone was currently using EMTs to vaccinate
 - Wesley Melson from LifeCare advised they're mobile vaccinating in conjunction with the Rappahannock Rapidan Health District and are starting with the use of Paramedics but will try to use EMTs when allowed
 - They are being given a list by the Health District of who is in need
- They have both bariatric units deployed
- The ET3 deployment plan is in process
 - They will work on alternate destinations in April
 - Treat in place, trying to get HER and physician billing in place
 - They are working on an October timeline

City of Fairfax Fire Department

Tom Olander advised there was no report

Fairfax County Fire & Rescue

Beth Adams provided the following update:

- They are also anticipating changes within the organization but have nothing solid yet
- 148th recruit school is in session and had a 100% pass rate on their NREMT
 - This is the first class with all internal instructors
- Paramedic class 2020-02 is just entering Phase 3 and will finish in two months
 - These will be a BLS only unit but an engine will follow with an ALS provider and ALS equipment

Fairfax County Police Helicopter Division

Paul DeHaven advised of the following report:

- They are doing well at Manassas Airport and the West Ox facility is still on target for completion
- They have several students currently in the VCU paramedic program
- They are currently doing interviews for a part-time paid OMD
 - The OMDs in the past have been volunteers

- Their paramedics did vaccinator training to be able to assist the local Health Department
- They recently completed additional Narcan training for officers

Fauquier County DFREM

Loudoun County Fire and Rescue

Dr. John Morgan reported the following updates:

- They started administering employee vaccines last Monday for themselves and MWAA
 - They received 900 doses for these vaccines
 - They are also using the former Nordstrom site at Dulles Town Center as a vaccine site
 - They have created a pod to get doses from the Health Department and are using their Paramedics to administer the vaccines
- They had their first two deployments of the Whole Blood program
 - Both were trauma patients
 - Once was an LCSO deputy who was shot at a local Walmart on a call

City of Manassas Fire and Rescue

Todd Lupton advised of the following update:

- Thank you to the Board, Executive Board, and office staff for all of the hard work on putting this Council in a great financial state
- They are working with the Health Department on providing vaccinators to assist them
- They are currently recruiting as they have 4 vacancies at this time
 - They recently lost 6 to other agencies in the region
 - They always have difficulty recruiting paramedics
- They are implementing new Zoll ventilators in March

City of Manassas Park Fire & Rescue

Aaron Schutt provided the following update:

- They are working on purchasing a new Braun ambulance
 - They are hoping for a June or July timeframe
- They received four Zoll ventilators and are working on the training for those now
- They do not have anyone in quarantine or isolation at this time
 - 11 employees have gotten their second vaccine dose
- Two new employees have started and are in their paramedic internship

MWAA

Christopher Gavurnik provided the following update:

- They still have a low traveler volume but it's slowly picking up
- Call volume is starting to pick up as well and there's more mutual aid
- 84% of their staff has started the vaccine process and 74% have had their second dose

Prince William County Fire and Rescue

EMS Captain Daniel Acosta provided the following update:

- They are working on vaccines for staff like other agencies
- Recruit school just finished and a new one is starting soon
 - They have 18 paramedics from the recent class

- They are doing an upgrade to their Lifepak 15s
- Dr. Sullivan advised they have about 60% of their staff vaccinated with the first shot being given about 2 weeks ago

PHI Aircare

Rick Cohen provided the following update:

- Aircare 6 will be in Culpeper around May 1, 2021. The aircraft is currently in Front Royal
 - They are upgrading to a 135 aircraft
- They have positions open and are interviewing now
- Debbie McIntyre has been with Aircare since the 1980s and is currently a supervisor in Fredericksburg. She is retiring next week

Physicians Transport

Kate Passow advised of the following update:

- They have no staff in quarantine or isolation at this time
- They remain busy
- Thanks to Inova for allowing their providers to be vaccinated under them

HCA Reston Hospital Center

Keith Morrison reported the following updates

- Their neuro bi-plane suite with GWU is going well
- They have partnered with Prince William County Fire & Rescue to host clinical rotations for their paramedic programs
- They have currently vaccinated approximated 4000 and are assisting the Health Department
- There is an upcoming education opportunity with trauma services and the helicopter
- They are down to 30 COVID patients being treated at the hospital
- In August 2021, they will have a free-standing Emergency Department in Tyson's Corner complete with CT, lab, x-ray, etc.

HCA StoneSprings Hospital

Pam Leins provided the following update:

- HCA Reston and StoneSprings Hospitals have a joint Facebook page called HCA Northern Virginia EMS
- They also started yesterday with paramedic clinical rotations with Prince William County Fire & Rescue
- They are well into their vaccination efforts and are vaccinating EMS, fire department, and law enforcement

- The construction on the Behavioral Health Unit is starting soon
- Free-standing Emergency Department construction to start at the end of the month
- Their bariatric surgery program will start toward the end of this month
- They are doing a blood drive with Red Cross at the Arcola VFD annex on the first Wednesday of the even months
- They now have an onsite OB hospitalist 24/7/365

Inova Fairfax Hospital

Mark Guditus reported the following update:

- Their sympathies go out to Loudoun County Fire & Rescue on their recent loss
- They have their Comprehensive Stroke Center visit later in February
- There is an overflow section for the ED for those who are identified as needing to stay 12+ hours
- Eric Reist from Inova Health System provided the following updates:
 - They currently have 187 COVID positive patients being treated
 - The hospitals peaked around January 18th
 - They are partnering with other hospitals and EMS agencies for blood donations
 - They are currently in a negative state for all types except for O- and A- blood
 - They are celebrating giving over 100,000 doses of the COVID vaccine at the Inova Center for Personal Health
 - This is 45% of all doses administered in Northern Virginia
 - They are working on a site in Alexandria
 - Kudos to Dr. Morgan on his impressive site in Loudoun County
 - Thanks to EMS providers for responding professionally when called to vaccine clinics for transports
 - They are looking to expand the Springfield facility and move Alexandria Hospital to the Landmark Mall site in the next 1-2 years
 - Strategic expansion is coming in the future

 - Kate Kramer from Arlington County Fire Department asked if 25mg of oral Benadryl could be added as they're using this for vaccination reactions
 - Craig asked that the exact wording be sent for the form to be updated
 - **MOTION:** Beth Adams made a motion to accept the form as provided with the anticipation to add 25mg oral Benadryl as requested by Arlington County
 - **SECOND:** Kate Kramer
